Greetings in the Lord from the Presbytery of Mid-America,

We hope all is well in the Presbytery the Central Carolinas. Thank you for your recent letter expressing your thoughts and concerns about Memorial Presbyterian Church's petition to join the EPC via the Presbytery of Mid-America. You are not alone in your communication as we have received a number of thoughts, opinions, and suggested guidance in the midst of our work and deliberation.

Pastorally, we discern that there is a level of anxiety surrounding this issue and that not being a part of Mid-America's process and day-to-day discussions have perhaps created uneasiness and angst for those on the outside. We are sympathetic to these dynamics. Therefore, in the hopes of caring well for our fellow presbyters, we have decided to share a brief update about our process thus far.

In addition to the standard work of evaluating the merits of the petition, which includes examining Memorial's teaching and ruling elders, the Presbytery of Mid-America recently voted to present the following overtures at the 44th General Assembly:

OVERTURE #1

The Presbytery of Mid-America overtures the 44th General Assembly to direct the Permanent Committee on Theology to examine the concept of sexuality as it pertains to identity/self-conception, progressive sanctification, and concupiscence, and to make recommendations to the 45th General Assembly on how these concepts apply to the examination of officers.

OVERTURE #2

Whereas, as ordained teaching and ruling elders we take vows promising subjection to our fellow Presbyters in the Lord and promise to be zealous and faithful in promoting the peace and purity of the church (BOG 13-5A); and Whereas, we are called by Scripture to be eager to maintain the unity of the Spirit in the bond of peace (Ephesians 4:3);

Therefore, be it resolved that the Presbytery of Mid-America overtures the 44th General Assembly of the EPC to direct the Permanent Committee on Ministerial Vocation to make recommendations to the 45th General Assembly on how churches and Presbyteries are to promote and preserve the peace of the church as it relates to the following questions:

- 1. To what degree (if any) should a local church's philosophy of ministry be subordinated to the will of the Presbytery if that philosophy causes or might cause division and disunity among member churches?
- 2. On what basis shall a Presbytery determine whether any instance of evangelistic effort or outreach unique to a local church threatens the peace, purity, and unity of the Presbytery or the EPC?
- 3. In the interest of outreach/hospitality to the unchurched community, shall we allow sessions in our denomination to permit use of church resources by secular groups which promote lifestyles and behaviors that overtly contradict God's design for human flourishing? If so, under what circumstances?

It is our intention to be exceedingly thorough and to solicit wisdom and guidance from the denomination to inform our deliberations and decision-making. We do not believe that moving quickly is healthy for anyone, particularly as it relates to the integrity of the process outlined in our Book of Order and also the desire to not unintentionally establish precedents that would complicate future considerations about similar matters. As a result, it is our intention to move forward slowly and methodically. We are not in any hurry.

We are committed to upholding the purity of the church without compromising the peace and unity of the church. Likewise, we are also committed to upholding the peace and unity of the church without compromising Her purity. Over the years, the EPC has established itself as a unique denomination that has found a way to be both doctrinally rigorous (biblical) and pastorally generous (gracious). We have been blessed by God to navigate important and challenging issues in the past while remaining united in the Gospel. We see the matter before us as simply another opportunity to continue being both biblical and gracious.

In the meantime, our hope denominationally is that each Presbytery will allow, and in good faith trust, the other Presbyteries to do the work set before them by our constitution, giving one another the benefit of the doubt that it will be done with Christian integrity and in alignment with God's Word.

In light of that, please continue to pray for us. We need the Lord's wisdom and guidance to carry out our Presbytery's work just as you all need the same to carry out your work. We invite you to participate with us in this way. While prayer is welcomed, we also want to share a potential wound we have felt from several correspondences we have received from various corners of our denomination. Given that we are instructed in Scripture to deal directly with fellow Christians where there is an offense (even though we are certain, in

this instance, it is unintentional), in that spirit we encourage you all to consider the following:

- We ask that you allow our connectionalism and Presbyterianism to function according to its design. As you all in New Rivers enjoy the authority to oversee the churches and territory entrusted to you, we likewise desire to faithfully represent Christ in our attempts to oversee the churches and territory entrusted to us.
- We believe there can be a danger for the EPC if we all seek influence or control over outcomes in other Presbyteries through pressure and parliamentary workarounds rather than through prayer and patience.

We understand it may be challenging to detect the tone of any letter, and so let us be clear that the above comments are offered with a Christian kindness that comes from a position of deep respect for you all. There is no angst or anger here, only a request that you would allow us to be faithful to the call on our lives as EPC Tneaching and Ruling Elders in the Presbytery of Mid-America just as we desire to honor you as you seek to be faithful to God's call on your work in your Presbytery.

Again, thank you again for your original correspondence. We recognize that it comes from a love for Christ and His Church and so we wanted to respond to you in an equal expression of love for our Savior and His bride by continuing the tone you set in being kind and gracious. May God bless the churches and members of all of you in New Rivers.

 - The Moderator addressed some needed changes in the Proposed Docket and asked if there was a motion from the floor to adopt the docket. The motion to adopt the updated docket was made, seconded, and approved unanimously by voice.
 - The Moderator entertained a motion to approve the minutes of the 5th Stated Meeting of the Presbytery of Central Carolinas.
 - Commissioners were reminded of the upcoming General Assembly June 18-20, 2024 and that registration is now open for "Early Bird" registration until May 16, 2024.
 - The Moderator also took to welcome to first-time commissioners and corresponding members.
- 06-05. A Video Presentation by Michelle Munger, Presbytery Information Technologies Specialist, was viewed explaining the new software the presbytery will be using called ChurchTrac. The video led the group through an orientation of how to register and use the software and the future web site updates being made available.
- 06-06. The Moderator recognized TE Robert Howard, Stated Clerk, who gave the following report. Three communications from the General Assembly entities are as follows:
 - The PCC has received communication from the General Assembly of the churches that have not submitted their 2023 Annual Church Reports. These Sessions are asked to submit their reports immediately.

• The PPC has also received a letter of information from the Benefit Resources of the General Assembly included in the packet. The PCC hosted a member of the Benefit Resources at the 5th Stated Meeting who reported on the resources available to members.

- 06-07. The Executive Council finalized and sent the Pastoral Letter to Presbytery of Mid-America concerning the reception of the Memorial Presbyterian Church and Pastor Greg Johnson. The letter suggested referring to the General Assembly for further guidance in this decision. Presbytery of Mid-America at its April 2024 meeting has delayed any actions and sent two Overtures, not yet available to the PCC, to the G.A. The Overture from New River Presbytery was included in the Presbytery Packet for help in preparing those who will be attending the General Assembly in June 2024.
- 06-08. The Executive Council also acted on obtaining property insurance arising from the closing of churches in the PCC. Two churches, Park Avenue PC and Troy PC, will be closing in 2024 and one will be deeding the property to the PCC soon. The issue of obtaining insurance on the property will be an expense for the PCC until the Presbytery votes on what to do with the property.
- 06-09. The Executive Council also received a report from the Ministry Committee who is seeking to finalize a draft procedure for Receiving Congregations from other Denominations. There is presently one church, Eureka Presbyterian Church, Carthage, NC, who has applied to join the EPC and Varennes Presbyterian Church, Iva, SC, who is in the discovery phase of the process.
- 06-10. The PCC has received motions from two Church Sessions that will need to addressed later in the meeting.
 - The Session of Valley Hope Community Church, Swannanoa, NC overture to concur with the Presbytery of the Pacific Northwest proposed changes to the Book of Order Chapter 8-2. C.; 8-3. B. 2. and Book of Worship 3-3. J.

- The Session of Lighthouse EPC motion that the Presbytery of Central Carolinas remove the secret ballot voting for approval of Pastoral Candidates following Examinations on the floor of Presbytery. This proposal will be addressed by the court at the beginning of the Ministerial Committee's Report.
- 06-11. The Attendance and Parity report for today's meeting is still short of two Ruling Elder Commissioners for every Teaching Elder at each Presbytery meeting.

Finally, the Stated Clerk reported that the PCC has 17 Church Session who have not submitted Session Minutes for 2021, 2022, and 2023 and are out of order.

There will be a Clerk of Sessions training during the dinner hour Friday evening. A motion to receive the Stated Clerk's report was made, seconded and approved unanimously.

- 06-12. The Moderator recognized RE Dan Barry, Moderator Elect and Chair of the Stewardship Committee, to bring that committee's report. RE Dan Barry reported that the 2024 YTD finances of the PCC are in a good place. An update of the Church Property issues of closing churches and the cost involved with insurance and upkeep until a decision is made by the PCC was explained to the court. A motion to receive the report was made, seconded and approve unanimously by voice vote.
- 06-13. The Moderator called RE Amy Russo and Shawn Stewart to bring a Report of the Missions Committee (Global Focus) The Missions Committee recommends that the PCC is ready to take on adopting a people group who have need of hearing the Gospel of Jesus Christ and offer the following motion:

Motion: "In accordance with the mission of the EPC to fulfill the great commission and aligned with our call as a presbytery to make bold efforts to live into that mission to Jerusalem, Judea, Samaria and to the utter most part of the

world, the Presbytery of Central Carolina Mission Team recommends the adoption of the Western Punjab people of Pakistan, as an Engage 2025 effort and in partnership with EPC World Outreach."

The motion did not need a second, coming from committee, and put to the court by the Moderator. The vote was made by asking people to stand in favor of the motion. The motion passed unanimously. RE Amy Russo moved that the Mission Committee be received. The motion was seconded and approved unanimously.

- 06-14. Order of the Day: Church Equipping Session Church Planting: Parent, Partner or Patron. RE Elizabeth Gibson, Chair of the Northampton Church Planting Network, addressed the court on the possibilities of church planting and why it should become a priority. RE Elizabeth Gibson introduced her husband, TE Cron Gibson, who led the court in a discussion on why church planting became important in his own ministry history and the results that came from God's work though those efforts. TE Anthony Rodriguez of Valley Hope was invited to give a brief history of how Valley Hope was a church plant by Christ Community Church – Montreat and now after a decade the Session began dedicating giving a small portion of their receipts to church planting and the benefits Vally Hope has received from that commitment. TE Mike Moses was invited by TE Rodriquez to bring the next portion of the presentation on church planting. TE Mike Moses asked TE Bill Wade of Overbrook and TE Logan Keck of Centre to help in a discussion of their involvement in taking up the challenge of becoming involved in church planting by seeking ways of partnering and contributing to church. TE Elizabeth Gibson announced and invited churches and individuals to the planned prayer walks on August 19th, 2024, in Swannanoa, NC and on August 20th, 2024, in Spartanburg, SC. These prayer walks are for the purpose of asking God to create an interest in those areas for an EPC church plant. The final part of the presentation was organized into three small groups to help churches discuss how they might take part in church planting through parenting a new church, partnering with a church planter or supporting financially a church plant.
- 06-15. The Moderator recognized the time of recess for Fellowship & Dinner and led the court in prayer for God the bless the food and the fellowship of the members gathered. A Worship and Celebration of the Lord's Supper was observed at 7:00 PM with TE Gabe Swing leading in preaching the Word of God and administering the Lord's Supper. The evening intercession focus was on the work of the Missions Committee work through the PCC. The offering was designated to the Barnabas Fund of the Presbytery of Central Carolinas. A prayer ministry and fellowship were made available after the close of the service for those in need of encouragement and intercession.

Saturday, April 27, 2024

06-16. At 8:30 AM Moderator TE Jim Braswell called the court to order and led the court in prayer to begin the business of the day. Chaplain Candidate Katie Piquette was invited to lead the court in a morning devotional message to satisfy the requirement for those seeking to be ordained in the EPC. Candidate Piquette preached from the Gospel of

Mark, Chapter 8 and her sermon focused on the calling to trust in Jesus in the mist of uncertain times and occasions of doubt. At the conclusion the Moderator entertained a motion to sustain this portion of the examination. A motion from the floor to sustain this portion of the examination (G. 12-2. D.) of Candidate Piquette was made, seconded, and approved unanimously.

- 06-17. RE Carol Williams, Presbytery of the Alleghenies, was invited to the stage and introduced by the Moderator as a member of the Ad-Interim Committee on "Pastoral Letter of Racial Lament and Hope." RE Williams brought an introductory video of the members of the committee who shared their work and hopes in writing this draft Pastoral Letter of Racial Lament and Hope. The need to speak on the issue of racism was the impetus for this draft and it is with humility. The collective purpose is to foster a unity through lament and hope that the committee offers this letter as a resource for our church members. The committee offers this draft and expects feedback from the Presbyteries of the EPC for further perfection. RE Williams invite the court to break into small groups using the following four questions to guide group discussion:
 - 1. How does this letter help you understand and address racism?
 - 2. Is there anything that is particularly encouraging?
 - 3. Is there anything that is particularly troubling?
 - 4. How do you see this letter helping the EPC?

RE Williams asked representatives to bring the groups' reactions and themes discussed in the group. There were various opinions shared about the draft and its success and failure in addressing issues individuals found or felt were not adequately expressed. Scripture and theological research were excellent and could have been more developed. Some felt that the paper was heavy on "white privilege" and had some air of Marxist thought not uniting and maybe further divisive. Others expressed the idea of lamentation was a good start to dealing with uniting in Christ in witnessing to the evil of racism. The Moderator thanked RE Carol Willaims for coming and leading the court in a review of this draft from committee.

06-18. RE Anita Hill was recognized by the Moderator to bring the report from Church Development Committee. RE Hill invited TE Rob McClelland, Church Health Coordinator, to give a report on the work of the Church Health Trainees and their work in the Presbytery.

Women's Retreat:

On April 6th, the women of our presbytery had a Regional Women's Gathering at Lake Forest/Huntersville with a focus on "Helping Women Deal with Difficult Situations in our World". A little over 40 women attended from many of our churches. The event was a success.

Small Church Network (SCN):

Corrina Gambrel has taken a call in at Cyrus Springs which is in the Coastal Presbytery. TE Mark Dickerson has agreed to step into will now lead the Small Church Network.

The committee asked Mark Dickinson to serve on the CDC and he agreed pending presbytery approval.

A networking dinner for small churches will be held during the April presbytery meeting at the Friday night dinner. Join us at Threshold once you pick up your dinner. Elizabeth Gibson will join us for a discussion regarding how to engage small churches in Church Planting.

Church Health:

We are following up with churches regarding the Missional Posture Assessment that attendees of presbytery completed in January. We found that it is beneficial for entire sessions to complete the assessment to get a broader and more complete view of the status of the church. We have contacted many pastors to see if they would like to proceed with this next step.

We are planning Refocus Workshop meetings. The purpose of this gathering is to assist churches in aligning perception with reality through self-discovery assessments, hands-on learning, and group interaction. The desired outcome is for the church to understand it's current health status and evaluate next steps to improve overall church health.

Our first workshop is scheduled to be at Siler Presbyterian the evening of September 26th. If you and your session are interested in joining us for this event, please contact Anita Hill.

We conducted training for our Church Health Coaches in Hendersonville on 3/16. Work continues to train health coaches and engage additional churches. We will continue our training on 4/25 and 4/26. Robert Wallace and David Taylor agreed to serve as coaches.

TE Rob McClelland asked that the Presbytery receive their report. The Moderator requested that the report be received by unanimous consent. The Motion was approved.

- 06-19. TE Logan Keck was invited to give the report of the Church Planting Committee. TE Keck gave a brief overview of the work the Church Planting Committee has undertaken in securing and building networks to help in future church planning. TE Keck invited TE Drew McCarty to give a brief overview of the work he is undertaking as an Evangelist with the Asheville Hope Misson Group. TE Keck explained, from the Book of Order, the difference between a "Mission Group" and a "Mission Church."
 - A mission group is the first stage in the development of a mission church. A mission group may be initiated by a Church court or by groups from outside the denomination recognized by a presbytery. Mission groups fall under the oversight of an appropriate committee or commission of a Church court. (G. 5-3)
 - A mission church is constituted by the presbytery and is distinguished from a local church in that it has no permanent governing body and must be governed or supervised by others as defined below. Its goal is to be established as a local church as soon as this can be done in good order. Mission churches enjoy the same status as local churches in relation to civil government. (G. 5-4)

On behalf of the Planting Church Committee, TE Keck offered the following motion:

Motion: The Church Planting Committee moves that the PCC would change the status for Asheville Hope from a "Mission Group" to a "Mission Church" and that the following individuals would serve as the Administrative Commission (G. 5-4. A. 3):

- TE Drew McCarty, Evangelist, Moderator
- TE Anthony Rodriguez, Valley Hope Church
- TE Brian Land, Grace Church, Brevard
- TE Howard Quach, Riceville Valley Community Church, Clerk
- RE Robert Wallace, Hendersonville Presbyterian Church
- RE Joe Kirk, Grace Church Brevard
- RE Ben Lillard, Vally Hope Church

The Administrative Commission has oversight of Asheville Hope Mission Church:

- Which includes the responsibility to receive members into the mission church as prescribed in G-8. Mission churches shall maintain membership rolls in the same manner as, but separate from, other local churches. (G. 5-4. B. 1)
- Instruct that the members of Asheville Hope Mission Church are entitled and subject to the benefits of discipline as described in the Book of Discipline. (G. 5-4. B. 2)
- And shall record and submit its minutes to the Presbytery for review in the same manner as a local church. (G. 5-4. C.)

The motion did not need a second from the committee and the floor was open to discussion. Hearing no discussion, the Moderator moved the question. The motion was approved unanimously.

06-20. Report from the Missional Director—TE Brian Land reported that he has been working with Rob McClelland, Church Health Coordinator, and RE Elizabeth Gibson Northampton Church Planting Network, which resources church planting in the Presbytery of New River, The Presbytery of Coastal Mid-Atlantic and the Presbytery of Central Carolinas on the problem of the pipeline in look and developing future leaders. TE Brian Land has taken the opportunity to meet with students interested in Church Planting at Reformed Theological Seminary in Charlotte NC in that endeavor. The General Assembly is also working to establish regional church planting coordinators in each of the presbyteries of the EPC. TE Brian Land moved the following motion:

Motion: That RE Elizabeth Gibson of the Northampton Church Planting Network be appointed as the Presbytery of Central Carolinas' Regional Church Planting Coordinator.

The Moderator asked if there was a "second" from the floor. The Motion was seconded and approved unanimously.

06-21. RE Amy Russo was acknowledged to bring a report from the Missions Committee (Local Focus). RE Russo led the court in brief prayer for World Outreach workers laboring in

hard places as well as prayers for those unsaved in our local area. RE Russo welcomed and introduced Mrs. Valarie Smith and Mrs. Susan Crace who lead "Mothers of Preschoolers at Threshold. They two mothers spoke of the vital and important role this ministry plays in reaching and supporting the families in the community. RE Russo asked that the Presbytery receive their report. The Moderator entertained a motion that the report be received by unanimous consent. The Motion was approved.

06-22. Concurrence of Ascending Overture from the Presbytery of Pacific Northwest.

The Moderator recognized TE Anthony Rodriguez who brought to the floor a motion for the PCC to concur with the Presbytery of Pacific Northwest's Ascending Overture to the General Assembly 2024. TE Anthony Rodriguez informed the court that the Session of Valley Hope met on March 11, 2024. Having examined the overture coming out of the Presbytery of the Pacific Northwest and finding its reasoning to be both theologically justified, consistent with our polity, and pastorally wise, The Valley Hope Church Session makes the following motion:

Motion: The Session of Valley Hope Church wishes to move that the Presbytery of the Central Carolinas concur with the Presbytery of the Pacific Northwest to amend the Book of Order with the following Ascending Overture approved by the P-PNW to the 2024 General Assembly in Memphis, TN.

[Begin Ascending Overture]

Proposed Ascending Overture to the EPC GA 2024 from the Presbytery of the Pacific Northwest

Whereas the Book of Order offers no path into church membership apart from verbal/ written "evidence of true commitment to Jesus Christ... and determination to live ...,"

Whereas, the covenant community includes baptized individuals, who are developmentally disabled, unable to profess faith and promise commitment,

Whereas, the words of Jesus Christ (John 9) clarify that infirmity, deformity and the like, may stem from the common curse, the suffering individual not at fault, the condition not a

consequence or punishment of his/her sin, but for the glory of God,

Whereas our Lord Jesus teaches us to know God as a Father who delights to give good gifts to his children far more abundantly than we can imagine (Matthew 7, Ephesians 3),

Whereas, in 1 Corinthians 11 the Apostle Paul more specifically defines "unworthy" participation in the Lord's Supper as "getting drunk" and/ or eating so much that one humiliates the poor "who have nothing to eat,"

Whereas the Westminster Confession of Faith 10.3 not only considers, "elect infants, dying in infancy," to be among the regenerate, but also, "elect persons, who are incapable of being outwardly called by the ministry of the word,"

Be it resolved that the Book of Order be amended by adding the italicized words below to the citations listed:

Book of Government, Chapter 8-2C

The Session shall satisfy itself that each applicant for membership demonstrates evidence of true commitment to Jesus Christ as Lord and determination to live as becomes a follower of Christ. It is appropriate for the Session to ask for testimonials of a personal relationship with Jesus Christ and a sharing of one's growth in faith. In the case of baptized, covenant children and adults, who are developmentally disabled, unable to demonstrate the above-listed evidence, the Session may consider them as members in good standing, admitting them to the Sacrament of the Lord's Supper.

Book of Government, Chapter 8-3B.2

Persons may be received into active membership in the following manner:

a. By profession of faith

Ordinarily the person(s) being received on profession of faith shall make that profession in a public service of worship in the presence of the congregation. If not previously baptized, each person shall be baptized in accordance with the Book of Worship as it deals with adult baptism. If already on the baptized roll, the person shall be transferred to the active roll. The Session may receive into active membership any baptized covenant child or adult, who is developmentally disabled, unable to cognitively and verbally profess faith.

b. By reaffirmation of faith

Persons who have previously made a profession of faith who apply for active membership may be unable to secure a certificate of membership or may wish to reaffirm their faith.

c. By transfer of membership

Persons may be received by transfer of membership from another Evangelical Presbyterian Church or from some other body recognized as a part of the true Church. The Session may not deny membership for any reason not related to profession of faith and obedience.

Book of Worship, Chapter 3-31

Baptized children may be admitted to the Lord's Supper provided they have appeared before the Session and professed their faith in a manner acceptable to the Session. At its discretion, the Session may admit such persons to full membership. Also at its discretion, the Session may admit to the table developmentally disabled persons who have been deemed members in good standing.

[End Ascending Overture]

06-23. Special Order: Motion from the Session of Lighthouse Church
The Moderator reminded the court that the next item on the docket designates 15 minutes
to discuss a motion from the Session of the Lighthouse Church. The Moderator
recognized TE Andy Schuster who presented the motion to the court concerning the
process of voting on candidates during the period of examinations.

Motion: The Session of Lighthouse EPC unanimous request that the Presbytery of Central Carolinas remove the secret ballot voting procedure for approval of Pastoral Candidates following Examinations on the floor of Presbytery.

There was some discussion over the proposal. The Moderator recognized those who spoke of the advantages and disadvantages to any changes. TE Don Fortson was recognized by the Moderator who proposed the issue be sent to the Ministerial Committee for discussion and that the committee would bring a recommendation to the Presbytery at the next Stated Meeting. The Motion to refer to committee from the floor and a second was recognized by the Moderator. After some discussion over the motion to refer the Moderator asked the court if it was ready to vote. Hearing no objections the question was but to a vote.

Substitute Motion: That the Presbytery of Central Carolinas refer this matter of whether to use ballots in voting on Candidates seeking to be ordained to the Ministerial Committee for study and to have a recommendation for the court at the next Stated Meeting.

The motion to refer was approved by a voice vote.

06-24. Report of the Ministerial Committee – RE Butch Hill. The Moderator recognized RE Butch Hill who introduced the candidate to be examined, Ms. Katie Piquette who obtained a M.Div. from Denver Seminary and seeks to be ordained as a Hospital Chaplain with the Veterans Affairs Hospital in Asheville, N.C. TE Butch Hill invited TE George Schwab to lead the Court in examining the candidate.

TE George Schwab asked Katie Piquette to share about her Christian experience and growth, her sense of call to the Gospel ministry, and her motive for seeking ordination in the EPC (G. 12-2. B.) Hearing of her faith and growth, TE George Schwab moved that the testimony portion of the exam be closed pending questions from the floor. The motion

was seconded from the floor. The Moderator asked if there were any questions. Hearing none the motion was placed before the Court.

Motion: That the testimony portion of the exam of Candidate Katie Piquette be closed and this portion of the exam would be sustained.

The Motion was approved by voice vote.

TE George Schwab moved to the next part of the exam (G. 12-2. C) and asked Katie Piquette the following questions for the Bible Content portion of the Exam. List the Ten Commandments. Discuss six judges from the book of Judges. What was the sin of Jeroboam? List in order all the books of the New Testament. Describe the temptation of Jesus. List some parables of Jesus. Did Paul write the Pastorals? Explain the counter evidence. Thinking of 2 Timothy 3:16, how is Scripture useful?

TE George Schwab made a motion.

Motion: That the Bible Content portion of the exam be closed, and this portion of the exam would be sustained pending questions from the floor.

The Moderator acknowledge a second from the floor and opened the floor to further questions for the Candidate. Hearing none. The Motion was approved by voice vote.

TE George Schwab asked the Candidate if she affirmed the view of Scripture found in Chapter 1 of the WCF? The Candidate answered in the affirmative. She was also asked what exceptions she has to the *Westminster Confession of Faith* and Catechisms. The Candidate gave not exceptions.

TE George Schwab made a motion.

Motion: That the Exception portion of the exam be closed, and this portion of the exam would be sustained pending questions from the floor.

The Moderator acknowledge a second from the floor and opened the floor to further questions for the Candidate. Hearing none. The Motion was approved by voice vote.

The Candidate was asked the following questions in theology and Sacrament. Do you subscribe to the Essentials of the Faith of the EPC without any reservations? Is Jesus the only way of salvation? What is your view on infallibility and inerrancy? Explain your view of Dispensationalism & if you hold this view. Discuss biblical passages that teach the authority of Scripture. Describe the Trinity. Which comes first in the *Ordo*, faith or regeneration? Why? Who should be allowed at the Lord's Table? Explain your eschatology. Being satisfied with her response, TE George Schwab made a motion.

Motion: That the Theology and Sacrament portion of the exam be closed, and this portion of the exam would be sustained pending questions from the floor.

The Moderator acknowledge a second from the floor and opened the floor to further questions for the Candidate. Hearing none. The Motion was approved by voice vote.

The next part of the exam covered Church History. The Candidate was asked to give answer to the following questions. What is the history behind the Apostle's Creed? What was it addressing? Who was Ulrich Zwingli? What sets the Reformed tradition apart from other movements? When did the EPC come into existence? In your view, what is distinctive about the EPC's paper on women's ordination? Tell us the story of Andrew Brunson.

Being satisfied with her response, TE George Schwab made a motion.

Motion: That the Church History portion of the exam be closed, and this portion of the exam would be sustained pending questions from the floor.

The Moderator acknowledge a second from the floor and opened the floor to further questions for the Candidate. Hearing none. The Motion was approved by voice vote.

TE George Schwab moved to questions on Polity asking the following: Who is the chair of the church development committee? Who has primary responsibility for preparing a budget? Who has primary responsibility for overseeing a worship service? Who has primary responsibility for moderating the Session meeting? Why is it important for a Session to make provision for courses of instruction to train Ruling Elders before they are ordained? Should a funeral always focus on the hope of the resurrection? How would you do this? Why should the Session call for days of prayer and fasting?

Being satisfied with her response, TE George Schwab made a motion.

Motion: That the Polity portion of the exam be closed, and this portion of the exam would be sustained pending questions from the floor.

The Moderator acknowledge a second from the floor and opened the floor to further questions for the Candidate. Hearing none. The Motion was approved by voice vote.

Finally, questions on the Office of the Minister and the Word were put before the candidate. Those questions included: How would you counsel a suicidal person? How would you counsel a teen struggling with gender dysphoria? Tell us about the presence of evil in your work.

Being satisfied with her response, TE George Schwab made a motion.

Motion: That the Office of the Minister and the Word portion of the exam be closed, and this portion of the exam would be sustained pending questions from the floor.

The Moderator acknowledge a second from the floor and opened the floor to further questions for the Candidate. Hearing none. The Motion was approved by voice vote.

Having sustained all the portions of the examine according to the Book of Order (G 12-2. A.– D.), TE George Schwab moved the following:

The Moderator acknowledge a second from the floor and opened the floor to further questions for the Candidate. Hearing none. The Motion was approved by voice vote.

Candidate Katie Piquette and all family and friends who were in attendance were excused from the meeting so that the court could discuss the Candidate and her examination. After discussion, ballots were passed out to the Commissioners to fill out and the vote on the Candidate were marked, gathered and tallied buy the Ministerial Committee. The Committee reported that the vote was in the affirmative on the ordination and installation of Candidate Katie Piquette to the Office of Word and Sacrament. Candidate Piquette was welcomed back into the room and informed of the affirmative vote.

The Presbytery shall hold the membership of any remaining members until such time as the individual members request transfer to another Christian church, following the stipulations of **G.**8-4.
